




This chart shows the total general purpose revenue Natomas Pacific Pathways Prep. Elementary School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Natomas Pacific Pathways Prep. Elementary School is \$6,168,156, of which \$5,286,638 is Local Control Funding Formula (LCFF), \$705,974 is other state funds, \$175,544 is local funds, and \$ is federal funds. Of the \$5,286,638 in LCFF Funds, \$477,630 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



# **Plan Summary [2023-24]**

#### **General Information**

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

The Natomas Pacific Pathways Preparatory Elementary School (NP3 ES) is a charter school authorized by the Natomas Unified School District. The School serves approximately 350 students. Nearly all of the NP3 ES students reside in the Natomas Unified School District's boundaries, with the remaining coming from outside of the area. The School's unduplicated pupils comprise 52% of the School's student body population with a higher percent of English Learners than the district as a whole. NP3 ES promotes students who are thoughtful, prepared, and engaged citizens. The School emphasizes conceptual understanding, and teaches the Common Core State Standards through year-long themes. The School focus on understanding, evaluating, and creating with the goal of providing our children the tools for citizenship and life.

#### **Reflections: Successes**

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

NP3 ES continues to provide a high quality education to the diverse student population. A review of available data and reports shows that NP3 MS has performed well, for example, in 2019, NP3 Elementary School earned 3 BLUE and 1 GREEN indicator on the 2019 California School Dashboard. Additionally, when comparing NP3 ES to 100 similar middle schools in California, NP3 ES ranks 6 on the ELA indicator, 1 on the Math indicator and 1 on the Chronic Absentee and Suspension Rate indicators. on the EL Progress indicator, NP3 ES ranks 26 among those 100 similar schools.

NP3 ES also performed well on the last given CAASPP test in 2019, with nearly more than half of all students (57%) meeting ELA standards which is above the County average (47%) and State average (50%). On the CAASPP Math test, 55% of NP3 ES students met standards, again above the County average (41%) and State average (44%).

When looking at the performance of individual student groups at NP3 ES, the data shows that African American, Hispanic/Latino, and Socioeconomically Disadvantaged students at NP3 outperform similar students in the County and State on both the CAASPP ELA and Math tests.

#### **Reflections: Identified Need**

On the California School Dashboard NP3 ES shows lower performance for English Learners and Socioeconomically Disadvantaged students. On the CAASPP test, African American, Hispanic/Latino and Socioeconomically Disadvantaged students perform lower than their peers at NP3, however they perform better than similar student groups in the County and the State of California.

### **LCAP Highlights**

The past two years have provided an incredible opportunity to reflect on educational practices and systems. NP3 ES has seen great success at educating diverse students in Sacramento, and has plans to not only continue to provide excellent educational programs but also to revise and improve them. Although the Pandemic created unprecedented challenges, it also shed a light on the important components of NP3 ES and led to a renewed intentionality and opportunity with the construction of our new campus at the same location as the middle and high schools.

With this new LCAP, NP3 ES is launching four new school goals focused on continuously improving outcomes for students. 1) NP3 will provide an outstanding educational program that promotes a student-centered learning environment, student growth, and academic achievement. 2) NP3 will provide equitable access to a broad course of study that is rigorous, culturally responsive, and relevant to promoting globally minded and civically engaged students. 3) NP3 will provide all students with a rich variety of rigorous standards-aligned learning opportunities that promote college and career readiness and preparation for a productive future as citizens in a global society. 4) NP3 will provide a safe environment that cultivates emotional security, promotes the wellness of all students, and facilitates responsible decision-making where students feel connected and engaged in school.

# **Engaging Educational Partners**

NP3 ES conducted a survey of our families in the Spring of 2022 to gather feedback about distance learning. School leaders communicate regularly with staff and families through a variety of methods including weekly "Matey Messages" (email), website updates, and regular communications from teachers. Staff facilitated a Back to School Night in August. Staff meetings were held regularly throughout the year and parent videos and parent nights were developed to keep families informed and engaged.

#### A summary of the feedback provided by specific educational partners.

Based on the feedback from our educational partners a few things stand out. For example, our partners feel like our school does a lot of things well, including academics, school climate, student engagement, and student wellness. Parents clearly want to be involved as well. Teachers may not realize how much theyre sharing and how much the administration is listing to their ideas. There is a need to do more family events and student activities. Finally, the next time, in student survey, we need to make the questions about "teachers" specifically, because "staff" is not a term that makes interprets that it includes teachers.

Through the annual LCAP survey, educational partners shared strong support for NP3, instructional programs and support for students. A separate survey was administered to students than parents/families and staff. The following results include the percent of parents/family and staff who agreed or strongly agreed with each statement, and the percent of students who said each statement was partially true, mostly true, or completely true.

#### A description of the aspects of the LCAP that were influenced by specific input from educational partners.

Educational partner input led to a number of changes and additions to the plan for reopening schools in 2021 including the purchase of technology devices and mifi internet devices for students; additional training provided to NP3 staff; and a focus on student engagement and support by teachers, counselors, and other staff; childcare assistance for staff. Moving forward, out of the Pandemic, the feedback from our educational partners has also influenced school systems and processes and will be used to plan for changes in school structures using what we've learned through distance learning. Many of these same actions will continue into 2023-2024.

With the new three-year LCAP, using educational partner feedback and informed by student data, school leaders reflected on previous goals and established new schools to carry the school forward into the next few years. Along with maintaining goals focused on outstanding academic programs, preparing students for their future, and creating safe and engaging school environments, this year a new goal was developed, focused on civics education. This new goal reads: "NP3 will provide equitable access to a broad course of study that is rigorous, culturally responsive, and relevant to promoting globally minded and civically engaged students."

In 2023-2024 NP3 will increase the FTE for teaching and counseling at the school to reflect additional student enrollments and school needs.

All actions were developed using a careful analysis of data and input from our stakeholders. These contributing actions are principally directed toward our unduplicated student population to help NP3 be effective in meeting the goals and the identified needs of the unduplicated student groups.

In the goals section of this plan, each action marked "yes" for contributing contains a detailed explanation of how that action is principally directed toward the unduplicated student population and effective in helping close equity and performance gaps and meet the goals of our LEA. We incorporated the language required by 5 CCR Section 15496 into the description of each specific action's language because each response is unique and specific to each contributing action in this plan. Our intention in doing this is to increase transparency for stakeholders when reading this plan so they can better understand the rationale behind each unique district-wide action. Many of these actions and services are being performed on a schoolwide basis in order to increase their overall efficiency and effectiveness.

After assessing the needs, conditions, and circumstances of our English Learners, Low Income Students, and Foster Youth students, we learned that their academic achievement was lower than the academic achievement for all students. To address this condition of our English Learners, Low Income Students, and Foster Youth students, we will take actions to improve instruction, provide them extra learning time, and provide academic interventions to address some of the major causes of lower academic achievement, including lack of prior educational achievement, fewer family resources, and language acquisition challenges.

Goal 1, Actions 2,3, and 9 provide needed extra supports and extra time for unduplicated students. These actions are being provided on a school-wide basis with the expectation that it will also benefit all students to improve their academic achievement. However, because of the lower academic achievement for these English Learners, Low Income Students, and Foster Youth, and because the actions meet needs most associated with the chronic stresses and experiences of prior educational achievement, fewer family resources, and language acquisition challenges we expect that the academic achievement for our English Learners, Low Income Students, and Foster Youth students will increase more than the average academic achievement of all other students.

After assessing the needs, conditions, and circumstances of our English Learners, Low Income Students, and Foster Youth students, we learned that their chronic absentee rate was higher than the chronic absentee rate for all students. To address this condition of our English Learners, Low Income Students, and Foster Youth students, we will take actions to increase the cultural awareness and responsivity of our staff as well as providing every student leadership opportunities to participate in their school in a wholistic framework across the school to address some of the major causes of higher chronic absentee rate, including lack of family challenges, financial issues, feelings of connectedness to school.

Goal 2, Actions 2 and 4 create more engagement and improved connections with their peers, staff and school. These actions are being provided on a school-wide basis with the expectation that it will also benefit all students to improve their chronic absentee rate. However, because of the higher chronic absentee rate for these English Learners, Low Income Students, and Foster Youth, and because the actions meet needs most associated with the chronic stresses and experiences of family challenges, financial issues, feelings of connectedness to school we expect that the chronic absentee rate for our English Learners, Low Income Students, and Foster Youth students will increase more than the average chronic absentee rate of all other students.

After assessing the needs, conditions, and circumstances of our English Learners, Low Income Students, and Foster Youth students, we learned that their resources for learning were lower than the resources for learning for all students. To address this condition of our English Learners, Low Income Students, and Foster Youth students, we will ensure that all of our students have a chromebook to use through our

1:1 technology program to address some of the major causes of lower resources for learning, including lack of financial resources available to purchase a home computer.

Goal 3, Actions 2 provide each student at our school with a Chromebook that can be used to access educational resources, conduct research, collaborate with others, write papers, and create works that demonstrate their learning. These actions are being provided on a school-wide basis with the expectation that it will also benefit all students to improve their resources for learning. However, because of the lower resources for learning for these English Learners, Low Income Students, and Foster Youth, and because the actions meet needs most associated with the chronic stresses and experiences of financial resources available to purchase a home computer we expect that the resources for learning

for our English Learners, Low Income Students, and Foster Youth students will increase more than the average resources for learning of all other students.

After assessing the needs, conditions, and circumstances of our English Learners, Low Income Students, and Foster Youth students, we learned that their chronic absentee rate was higher than the chronic absentee rate for all students. To address this condition of our English Learners, Low Income Students, and Foster Youth students, we will provide counseling supports and a school-wide focus on restorative practices to address some of the major causes of higher chronic absentee rate, including lack of social emotional issues and connections with other students.

Goal 4, Actions 3 and 6 create better relationships and support for our students to remove barriers to learning. These actions are being provided on a school-wide basis with the expectation that it will also benefit all students to improve their chronic absentee rate. However, because of the higher chronic absentee rate for these English Learners, Low Income Students, and Foster Youth, and because the actions meet needs most associated with the chronic stresses and experiences of social emotional issues and connections with other students we expect that the chronic absentee rate for our English Learners, Low Income Students, and Foster Youth students will increase more than the average chronic absentee rate of all other students.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

The proportionality percentage to increase or improve services has been calculated at 8.8%. Our LEA has demonstrated that it has met the 8.8% proportionality percentage by planning to expend 28% which is more than the minimum required supplemental and/or concentration funds on actions or services such as academic supports, technology, counseling, and extra time for learning are principally directed towards

the unduplicated student population as summarized in the prompt above and as explained in detail in each contributing action description within this plan.

# Introduction and Instructions

These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100 percent attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
